## TZEACHTEN PROPERTY TRANSFER TAX RETURN

*Tzeachten Property Transfer Tax Law 2013*

- The transferee must file a return for each transfer of an interest in land even if no property transfer tax is payable.
- The transferee must file a return and pay all taxes payable on or before the due date in order to avoid penalties and interest.
- For late payments, a penalty of 10% will be assessed. Interest accrues in unpaid amounts at a rate of 15% per year
- Payments must be made at the offices of the Tzeachten First Nation Lands and Taxation office at **#29-6014 Vedder Rd, Chilliwack, BC V2R 5M4**, by Cash, Cheque or money order made payable to Tzeachten First Nation.  
**(this payment must be cash or in a separate cheque or money order and cannot be combined with registry fees.)**
